## **Alliance Against Cybercrime**



Leandra Ramm, a renowned singer and performer, was the victim of an eight year ordeal by a vicious cyberstalker from Singapore. The offender, a Mr. Coli Mak, was a convicted arms dealer who became obsessed with Ms. Ramm, He sent her countless emails threatening her and her family with graphic disgusting death threats from 2005 through 2013. With the untiring efforts of Mr. A.J. Fardella,, a digital forensics examiner and cybercrime expert, evidence identifying Mak as the perpetrator was secured. However, getting the authorities to do something was equally, if not more difficult, than solving the case. Ultimately, with the assistance of CII members Galen Clements, Sheila Ponnosamy, Ponno Kalastree, and Sant Jayagram, the authorities in Singapore were able to successfully prosecute Mak. In December 2013 he was sentenced to three years in prison. Ms. Ramm's night-marish experiences motivated her, Mr. Fardella, and others to form the Alliance Against Cybercrime. The goal is to provide education, application, research and advocacy for victims of this crime. The ACC is currently focusing on the "Ramm Initiative" to reform international treaties to address cyber harassment and strengthen existing provisions. Towards this goal, CII has formed an informal strategic alliance with the ACC.. The Conference Committee is pleased to have members of the Alliance Against Cybercrime present at our Awards Luncheon to tell us more about Ms. Ramm's journey from hell and back and more importantly, her courage in the face of adversity. They will also explain their mission and how we can work together to combat this terrible crime.
